- Regular Membership:** the members of which shall be entitled to vote at all meetings of members;

Doctorate of Natural Medicine (DNM®)

- Must be currently registered with and hold a DNM designation, with the Examining Board of Natural Medicine Practitioners (EBNMP) – Canada.

- Associate Membership:** the members of which shall be entitled to the same rights as regular members, but shall not be entitled to be elected as directors. Associate members shall meet the criteria of one of the following two categories:

Category A: The Associate member shall hold one of the following designations and must hold current registration with EBNMP – Canada.

Registered Naturotherapy Practitioner (RNP®)

- successful completion of at least 2500 hrs. of post secondary study from an accredited college in Nutritional Medicine, Botanical Medicine, Manual Medicine and Homeopathy.

Registered Acupuncture Practitioner (RAP®)

- successful completion of at least 2000 hrs. of post secondary study from an accredited college in Traditional Chinese Medicine and Acupuncture.

Registered Lifestyle Management Practitioner (RLMP®)

- successful completion of at least 1000 hrs. of post secondary study from an accredited college in Lifestyle and Wellness management

Registered Nutritional Medicine Practitioner (RNMP®)

- a practitioner who has completed at least 1000 hours of study from an accredited college in Nutritional Medicine.

Category B: Other Wholistic Practitioners currently not registered with EBNMP-Canada (you are strongly encouraged to do so)

- Student Membership:** The members of which shall be entitled to the same rights as regular members, but shall not be entitled to be elected as directors. Associate members shall meet the criteria of one of the following two categories:

- Student of the Wholistic Arts or in a Health-related field currently studying towards a DNM designation with EBNMP – Canada;
- Student of the Wholistic Arts or in a Health-related field currently NOT studying towards a DNM designation with EBNMP - Canada

Affiliate Membership: The members of which shall shall not be entitled to vote or to be elected as directors.

Associate members shall meet the criteria of one of the following two categories:

- In a health-related field; or in the health industry (product manufacturer, supplier, or distributor);
- In the Wholistic field and providing a service that benefits people in the Wholistic arts.
